Call to order at 6:02 PM via Zoom.

Approval of Minutes: Mrs. Elizabeth Johnson, Principal of Alvey Elementary school introduced herself. Mrs. Johnson made a motion to approve the minutes of the January 21,2025 meeting, Erin Heltzel seconded the motion. The motion passed.

SAC Updates: Mrs. Johnson asked Mrs. Norman to update the council on the information she was given from her last meeting.

Instructional Shifts

Math: Student's primarily representing and analyzing provided dates -----à Student's owning the entire data cycle

English Language Arts: Variety: whole language, guided reading, balanced literacy ----à Systematic explicit instruction

All Content Areas

Rote memorization of information and facts -- à Application of information learned and/or presented

Rote memorization of information and facts -- à Higher order thinking and critical thinking

Teachers give students all the information they need --à Inquiry Design (students provided a variety of information/sources, they draw conclusions of meanings)

Multiple choice assessments--à Balance of assessments to also include performance tasks, use of rubrics, student choice, technology enhanced items

Instructional Updates 25-26: Mrs. Johnson reported that ELA is HMH which the county purchased and trained teaching staff. Math will be a high-quality program, but it has not been identified for staff. It will align with SOL standards much like the ELA HMH and teachers will receive training once it is adopted in June. Social Studies will have new standards but no resources yet. There will not be any changes to science. VALLSS is expanding to K-8 which screens for phonological issues in early readers, so no student is left behind.

Staffing and Budget Updates 25-26: Mrs. Johnson reported that as of February Alvey is reported to have 491 students, which is under 500, so we are considered a small school. This qualifies Alvey with a supplement of \$118,000, however if our numbers go over 500 after September 30th Alvey will have to reimburse the county the \$118,000. So, this makes hiring staff difficult since you do not know if the numbers will change. At this time Alvey is predicted to have the following staff:

- 1.5 Counselors not 2
- 1 gifted teacher
- 3 Kindergarten
- 3- 1st grade
- 3 2nd grade
- 3 3rd grade
- $4 4^{th}$ grade
- 4-5th grade
- 2-year-old Pre-k AM class

Pre-K PM class -6-6 peer model

Cell Phone Policy: Mrs. Johnson explained that PWCS will have a new cell phone policy that will affect all schools from elementary to high school starting August 1st.
